CHAPTER 44-3

Property Subject to Taxation

SECTION 44-3-4

§ 44-3-4 Veterans' exemption. – (a) The property of each person who served in the military or naval service of the United States in the war of the rebellion, the Spanish-American war, the insurrection in the Philippines, the China-relief expedition, or World War I, and the property of each person who served in the military or naval service in the United States in World War II at any time during the period beginning December 7, 1941, and ending on December 31, 1946, and the property of each person who served in the military or naval services of the United States in the Korean conflict at any time during the period beginning June 27, 1950 and ending January 31, 1955 or in the Vietnam conflict at any time during the period beginning February 28, 1961 and ending May 7, 1975 or who actually served in the Grenada or Lebanon conflicts of 1983-1984, or the Persian Gulf Conflict, the Haitian conflict, the Somalia conflict, and the Bosnian conflict, at any time during the period beginning August 2, 1990 and ending May 1, 1994, or in any conflict of undeclared war for which a campaign ribbon or expeditionary medal was earned, and who was honorably discharged from the service, or was discharged under conditions other than dishonorable, or who, if not discharged, served honorably, or of the unmarried widow or widower of that person, is exempted from taxation to the amount of one thousand dollars (\$1,000), except in : HOPKINTON 6,700
