Zoning Ordinance Amendment and Zoning Ordinance Text Amendment

Consider a request for withdrawal of zoning ordinance text amendment received on November 13, 2009 regarding:

A Petition for a zoning ordinance text amendment filed by N.E. Ventures, LLC, 15 Wellstown Rd., Ashaway, RI, with Renova Lighting Systems, Inc. as lessee, for property owned by N.E. Ventures, LLC located at 15 Wellstown Rd. and identified as Assessor’s Plat 4 Lot 22 a Manufacturing Zone. The applicant is requesting an amendment to Chapter 131 “Groundwater and wellhead protection ordinance” and District Use Table and Primary Aquifer Zone of Chapter 134, Section 16 of the Zoning Ordinances of the Town of Hopkinton as amended.

A Petition to consider a zoning ordinance amendment received on November 13, 2009 and filed by N.E. Ventures, LLC, 15 Wellstown Rd., Ashaway, RI, with Renova Lighting Systems, Inc. as lessee, for property owned by N.E. Ventures, LLC located at 15 Wellstown Rd. and identified as Assessor's Plat 4 Lot 22 a Manufacturing Zone. The applicant is requesting an amendment to Chapter 134 of the Zoning Ordinances of the Town of Hopkinton, as amended, to permit all manufacturing uses to be permitted on AP 4 Lot 22 so as to remove the restriction imposed by the Town Council on June 4, 2007, specifically Restriction No. 10 which states in part "10(a) That the use of this property is strictly limited to the light industrial use proposed by the applicant. Specifically, this use shall be, "the design, engineering and assembly of lighting systems".
