BID REQUIREMENTS

1. Sealed bids will be accepted in the Town Clerk's Office until 3:00 p.m. on Thursday, April 25th, 2019.
2. Sealed bids will be opened in the Town Hall Council Chambers at 3:15 p.m. on April 25th, 2019.
3. Sealed envelopes must be marked "**SALE OF USED POLICE VEHICLES**".
4. Proposals shall be submitted on the attached bid sheet.
5. Bids are to be submitted on or before the date and time due and signed by a person authorized to represent the bidder.
6. **Vehicles may be viewed for inspection on April 18th, 2019 between the hours of 9:00 a.m. and 3:00 p.m. at the Hopkinton Police Station, 406 Woodville Road, Hopkinton, RI 02833.**
7. The Town of Hopkinton reserves the right to reject any or all bids and to accept the bid that is most acceptable. In addition, the Town expressly states that any costs incurred as a result of responding to this request shall be borne by the agency or person submitting the bid, not the Town.
8. Bids that do not meet minimum requirements shall not be considered. All exceptions must be listed.
9. Vendors are required to submit three (3) copies of their bid(s).
10. No bidder may withdraw his bid within ninety (90) days after the bid is submitted.
11. Payments must be made by bank check or cash. No personal checks will be accepted.
12. All vehicles are sold "As Is".
13. All sales are final.
14. **Bids will be accepted for police cars on an individual basis. Bidders may bid on one or more used police vehicles. No total bids will be considered.**
15. There are three (3) used police vehicles for sale.
16. Bids shall be awarded to the highest bidder on each individual used police vehicle.
17. The Town reserves the right to reject any or all bids, to waive technical deficiencies or informalities, and to accept any bid that it may deem to be in the best interest of the Town.

18. Bidders may be asked to appear before a committee comprised of Town officials to present their proposals and qualifications.
19. The Town of Hopkinton is exempt from Federal excise taxes and States sales tax.
20. Copies of the Request for Proposals (RFP) may be obtained at the Town Hall, 1 Town House Road, Hopkinton, Rhode Island between the hours of 9:00 a.m. and 4:00 p.m., Monday through Friday, and are also available on the Town's website, www.hopkintonri.org.
