

## NOTICE

The Town of Hopkinton currently maintains a community emergency notification telephone system known as "Code RED". It is a telephone message service, free of charge, which delivers automated telephone calls, within minutes, to those individuals whose telephone numbers are in the system.

Code RED is an emergency notification service by which town officials can notify Hopkinton residents and businesses by telephone, cellular phone, text message, or email about time-sensitive emergency situations or important community alerts. The system is capable of sending messages only to specific neighborhoods or the entire town.

**RIGL 44-7-7** The sending of this tax notice is required by law, failure to receive this notice DOES NOT waive the tax or penalty.

**RIGL 44-7-11 (f)** Collectors to furnish statement of liens including RP and MV on Municipal Lien Certificate.

**RIGL 44-5-13.10** New Construction-The Town of Hopkinton has the authority to assess a tax against new construction.

Separate bills are being mailed for Real Estate, Personal Property and Motor Vehicles.

**Tax Payments are due quarterly.** The due dates are September 8th, December 8th, March 8th, and June 8th. The Town of Hopkinton will be conducting two (2) Tax Sales per year. If tax is past due for (2) two quarters, property is subject to Tax Sale. The Town of Hopkinton may require payment in full to be removed from the Tax Sale.

If your Total Tax on this notice is \$100 or less, it must be paid in full at the 1st quarter.

There is a ten (10) calendar day grace period immediately following each installment.

**Please mail proper coupon with each payment.** If a receipt is requested, please enclose a SELF-ADDRESSED STAMPED ENVELOPE. Please send email address and we will email receipt.

**Please notify Tax Collector's office of any change of address.**

**NO SEPARATE BILL IS MAILED TO YOUR MORTGAGE COMPANY.** The property owner is responsible for all taxes. If your bank remits payment for your Real Estate Taxes you must forward this bill to them. (Make a copy for yourself).

If you have a **Tax Block at the DMV** and a **Registration Approved** stamp is required the taxes on your Motor Vehicles must be paid in full. Payment must be made by Money Order, Bank Check, Credit Card (fee charged) or Cash to be unblocked immediately. If paid with Personal or Business check we wait 15 days for check to clear.

A \$30.00 Fee will be charged for any returned check. Returned Checks are not Re-Deposited.

**If the remaining or any subsequent installment is not paid before the due date, the whole tax or any balance thereof shall at once become due and payable with a per annum interest of 12%.**

You will need your Account Number and your Pin Number which are available on your Tax bill.

## Real Estate and Personal Property Assessments:

Title 44 of the Rhode Island General Law specifies the method to follow when appealing an assessment. The filing of an Annual Return (44-5-15) on or before January 31<sup>st</sup> of each year is a pre-requisite to an appeal. **Chapter 44-5-26 gives an appeal deadline of ninety (90) days after the first payment is due to appeal to the local Assessor, and thereafter to the Board of Review.**

## Motor Vehicle Excise Information:

STATE LAWS: 44-34-2 requires the Town to tax for the privilege of registration, prorated for the number of days registered. 44-34-11 states that the assessment is based upon the average retail value, not the value of your particular vehicle. **44-34-8 sets the appeal deadline at forty-five (45) days after the Tax Notices are mailed.**

## Summary:

You are assessed a tax for your registration, not your car.

**Assessment for this Tax Notice is based upon year 2018**

**registrations.** The tax is based upon the average retail price of your vehicle's year, make and model as set by the State. The tax must be paid as long as the registration plates are active in your name, even if you no longer have the car. If you leave the state, you must return your plates and registration to the RI Division of Motor Vehicles to avoid tax. Bring a copy of the cancellation to the Assessor's office.
